Further, the biggest seaport and industrial hub of North Vietnam – Haiphong city has invested massively in state-of-the-art multimodal infrastructures. The first ship in the direct shipping route to US was recently launched in April 2019, minimizing transportation time and risk. These developments together with other advantages (such as the proximity to the Chinese market as well as the economic zone tax package) bring tremendous business opportunities for manufacturing, logistics and service companies.

For Hong Kong-based businesses to take full advantage of those developments, the Trade Office of Vietnam Consulate to Hong Kong, together with experts from DEEP C Industrial Zones, Deloitte Vietnam, Bank of China and Navigos Search are going to share insights regarding recent developments and the key factors to successfully planning your business in Vietnam.
