## US : Implementation of Additional Tariffs on US\$200 billion of Mainland Products under Section 301 Investigation

The US Trade Representative (USTR) released on 17 September 2018 the **finalized list of approximately US\$200 billion worth of Mainland imports** that will be subject to additional tariffs. In accordance with the direction of the US President, the additional tariffs will be effective starting 12:01 a.m. eastern daylight time on **24 September 2018 (US time)**, and initially will be in the amount of **10%**. Starting **1 January 2019**, the level of the additional tariffs will increase to **25%**.

**美國：根據「301 調查」對價值 2,000 億美元的內地產品徵收額外關稅**

美國貿易代表於 2018 年 9 月 17 日公布對價值約 **2,000 億美元**的內地進口產品徵收額外關稅的**最終清單**。在美國總統的指示下，額外關稅將由 **2018 年 9 月 24 日凌晨 12 時 01 分**（美國東部日光時間）起生效，稅率最初將為 **10%**。由 **2019 年 1 月 1 日**起，額外關稅水平將提高至 **25%**。
