**加拿大：對若干超出配額的進口鋼產品實施臨時保障措施（25%關稅）**

加拿大於 2018 年 10 月 11 日公佈一項臨時保障措施，對以下 7 種鋼產品實施關稅配額：(1) 厚鋼板，(2) 混凝土鋼筋，(3) 能源用鋼管產品，(4) 熱軋軋鋼板，(5) 預塗鋼，(6) 不銹鋼條，及 (7) 鋼絲棒。措施於 2018 年 10 月 25 日起生效。

**Canada : Provisional Safeguard Measures (Tariff-rate Quota) on Certain Steel Imports – 25% Surtax for Exceeding Specified Quota**

The Government of Canada announced on 11 October 2018 that Canada is imposing provisional safeguards, in the form of tariff rate quotas (TRQ) on imports of seven steel products: (1) heavy plate, (2) concrete reinforcing bar, (3) energy tubular products, (4) hot-rolled sheet, (5) pre-painted steel, (6) stainless steel wire, and (7) wire rod, which will take effect on **25 October 2018**.
