### Section 301 Exclusions (Guidance Document on Filing Entries Subject to Product Exclusions)

Further to our notice of 4 January informing members that the US Customs and Border Protection (CBP) will not be able to implement the first batch of Section 301 tariff exclusions until the impasse over government funding is resolved, the CBP announced on 8 February that the Automated Commercial Environment (ACE) will be available for acceptance of products excluded from Section 301 duties **on 10 February 2019**.
