## 人才清單

政府於2018年8月28日公布了首份香港人才清單，旨在吸引來自世界各地的優秀人才，以更有效和聚焦的方式配合香港經濟的高增值及多元化發展。人才清單包含下列11項專業：

- (a) 資深廢物處理專家；
- (b) 資深資產管理專才；
- (c) 資深海運保險專才；
- (d) 精算師；
- (e) 資深金融科技專才；
- (f) 資深數據科學家及網絡安全專家；
- (g) 創新及科技專家；
- (h) 造船師；
- (i) 輪機工程師及船舶總管；
- (j) 創意產業專才；及
- (k) 爭議解決專才及業務交易律師。

2. 為吸引世界各地人才來港，政府將通過「優秀人才入境計劃」按現時年度的1,000個配額，為人才清單下合資格人士提供入境便利。在「優秀人才入境計劃」下，獲批准的申請者無須在來港定居前先獲得本地僱主聘任。符合人才清單相關專業資格的申請者，可在「優秀人才入境計劃」的「綜合計分制」下獲得30分額外分數。「優秀人才入境計劃」已由2018年8月28日起接受人才清單下合資格人士的申請。

MEMORANDUM TO ALL MEMBERS

### Talent List

On 28 August 2018, the Government promulgated the first Talent List of Hong Kong which aims at attracting quality people from around the world in a more effective and focused manner to support Hong Kong's development as a high value-added and diversified economy. The Talent List contains 11 professions as follows:

- (a) Experienced waste treatment specialists;
- (b) Experienced asset management professionals;
- (c) Experienced marine insurance professionals;
- (d) Actuaries;
- (e) Experienced fintech professionals;
- (f) Experienced data scientists and cyber security specialists;
- (g) Innovation and technology experts;
- (h) Naval Architects;
- (i) Marine engineers and superintendents of ships;
- (j) Creative industries professionals; and
- (k) Dispute resolution professionals and transactional lawyers.

2. Immigration facilitation is provided to eligible persons under the Talent List through the Quality Migrant Admission Scheme (QMAS) within its existing annual quota of 1,000. Successful applicants under the QMAS are not required to have secured an offer of local employment for settlement in Hong Kong. For applicants who meet the specifications of the respective profession under the Talent List, 30 bonus points will be given under the General Points Test of the QMAS. Application under the QMAS for eligible persons in the Talent List opened on 28 August 2018.
