Manpower Projection to 2027

The Government is conducting a survey and consultation exercise in preparation of the “Manpower Projection to 2027”. The Manpower Projection aims to assess the broad trends of Hong Kong’s future manpower supply and requirements at the macro level in the medium term, thereby facilitating related policy formulation.

The Labour and Welfare Bureau has commissioned the Census and Statistics Department to undertake two exercises for this Manpower Projection, namely:
(1) 2017 Establishment Survey on Manpower and Job Skills Requirements; and
(2) consultation with stakeholders to gather views on the outlook of manpower requirements in various industries.

(1) 2017 Establishment Survey on Manpower and Job Skills Requirements

The 2017 Establishment Survey on Manpower and Job Skills Requirements aims to collect information on the current and future manpower and job skills requirements of different industries, which will be a reference for preparing the input parameters in projecting the future manpower demand in Hong Kong. The sampled establishments will be required to provide information on the number of persons engaged as at end September 2017 and future manpower needs, as well as job skills requirements.

(2) Consultation on various industries’ outlook on manpower requirements

The Census and Statistics Department will also conduct a consultation exercise in December 2017 with leading companies, chambers of commerce and trade associations. The exercise aims to solicit views and insights regarding the anticipated growth trends, changes in occupation mix in manpower requirements, new and emerging business prospects and opportunities and relevant implications for future manpower demand in specific industries. An officer from the Census and Statistics Department will visit the selected organisation with its prior agreement to conduct the consultation
