

MEMORANDUM TO ALL MEMBERS

**Seminar on Knowing the Competition Ordinance:
Meeting with Ms Anna Wu, Chairperson of Competition Commission**

The Competition Ordinance, passed by the Legislative Council in June 2012, established the Competition Commission to implement the competition rules. The Commission is required under the Ordinance to develop a set of guidelines which will:

1. indicate how the Commission will interpret and give effect to the First and Second Conduct Rules and the Merger Rule;
2. set out how applications for a decision or block exemption order are to be made and handled by the Commission;
3. indicate how complaints may be made; and
4. outline procedures for deciding whether or not and how to conduct an investigation.

To develop and finalise the guidelines, the Commission will approach major stakeholders, inform them of the Commission's preliminary thinking and hear their expectations on the guidelines. The Commission is expected to publish the draft guidelines in September and undertake consultation with the Legislative Council, stakeholders and the public. The FHKI will hold a meeting with the Competition Commission and Ms Anna Wu, Chairperson of the Commission will attend the meeting. Members are urged to come to express your expectations on the Commission and voice your views on the priority of its work and talk about your trade practices so that the Commission will understand the concern you have regarding the competition issue.
